

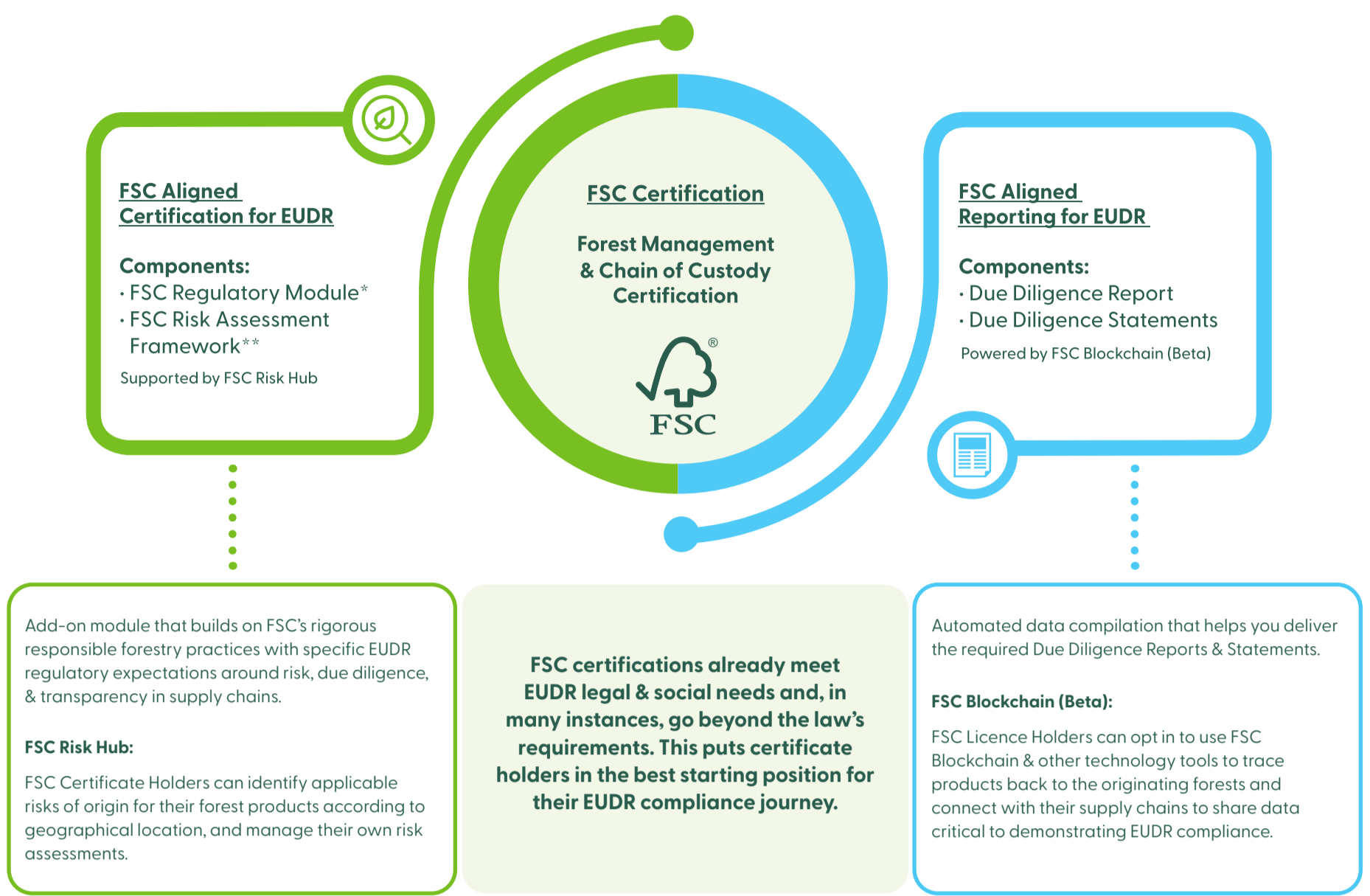

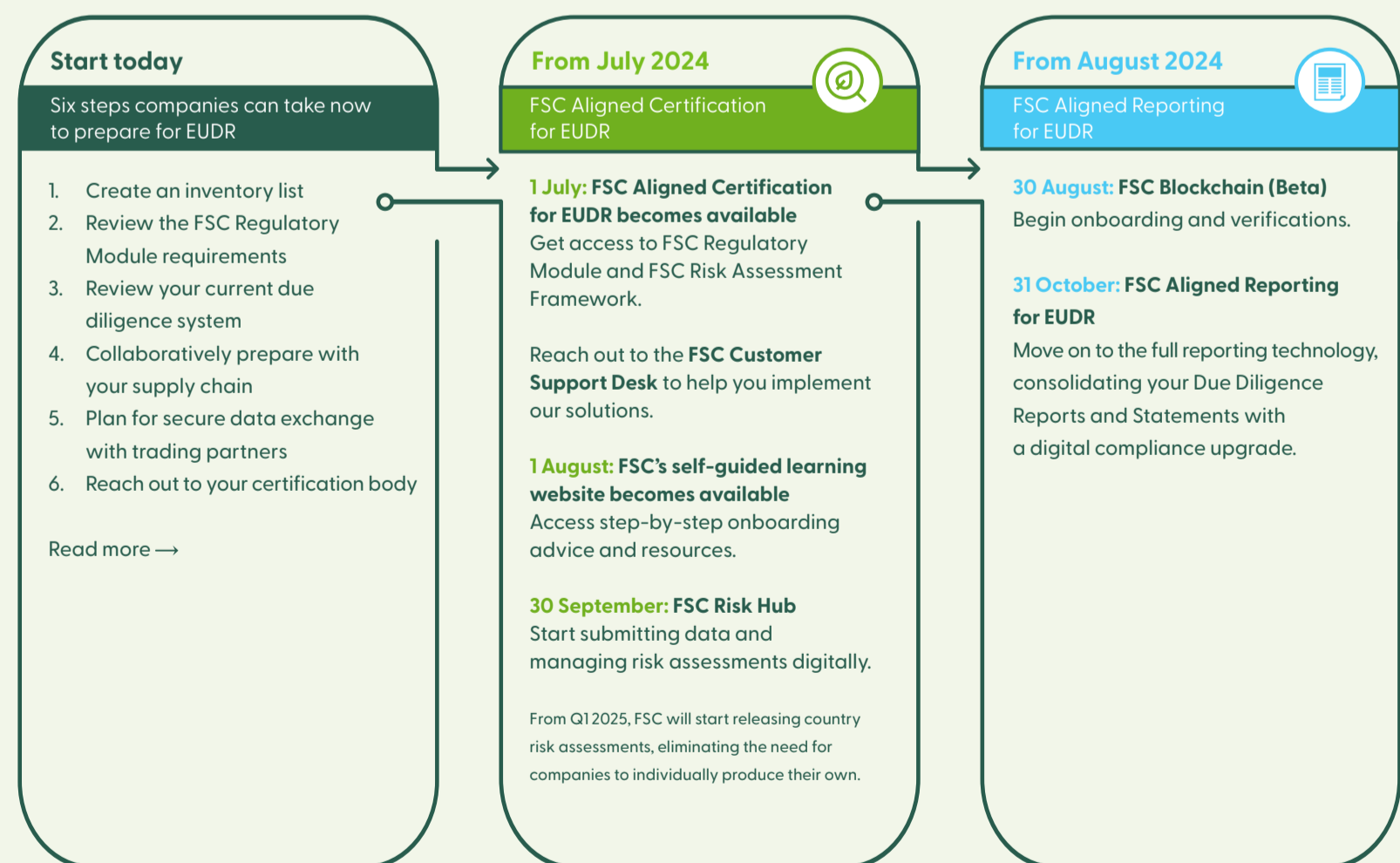
### THE EUDR DEADLINES



**30 December 2024** Medium & large companies must comply

**30 June 2025** Micro & small enterprises must comply
