Call for Proposal FSC Remedy Forum

Background

In July 2023, the Forest Stewardship Council (FSC) introduced an innovative approach to addressing social and environmental harms caused by forest conversion and destruction of high conservation values, with the FSC Remedy Framework. The Framework promotes restoration through both social and environmental remedy. In line with FSC's reputation as the most rigorous and trusted forest certification system, the Remedy Framework is composed of standardized requirements for restoration to promote social and environmental remedy.

Introduction

The Remedy Forum aims to increase the understanding about the benefits and opportunities of the remedy implementation. The forum will focus on facilitating collaborative discussions on remedy processes with a strong focus on forest restoration and community livelihoods. Through expert insights, interactive discussions, and knowledge exchange, the event seeks to provide a space to bring stakeholders to discuss enabling conditions, showcase innovative approaches, provide pathways as well as analyze the challenges or information gaps on environmental and social remedy in the Asia-Pacific region.

The Remedy Forum is intended to showcase the potential of the FSC Remedy Framework. The forum also has the intention to create engagement and strengthen partnerships across stakeholders, including local government, researchers, experts, NGOS, CSOs, organizations, indigenous peoples and local communities. Through the sharing sessions the forum will be able to generate actionable recommendations and strategies to better implement the remedy framework.
